### Position Responsibilities:

- Animal care and nature center cleaning
- Contributing to written publications,
- General area maintenance consisting of mowing, trimming, painting, light construction
- Litter control, restroom and facility cleaning, trail maintenance
- Provide public relations throughout the summer
- Program development and implementation, and
- Other duties as assigned
- Working some weekends, evenings, and holidays may be required.

### Qualifications:

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

**Education, Experience and Skills Required:**

- High school diploma or GED
- 18 years of age
- Valid driver's license with clean driving record
- Ability to operate mowers, small hand tools and chain saws

**Preferred Skills:**

Preference will be given to applicants working towards a degree in the Natural Resources or related field.

**Physical Demands/Work Hours:**
