Position Responsibilities:

- General park maintenance and facility maintenance
- Mowing, trimming and trail maintenance
- Cleaning restrooms

- Helping with environmental education programs
- Other duties as assigned

Qualifications:

Education, Experience and Skills Required:

- High school diploma or GED
- 18 years of age
- Valid driver's license with clean driving record.
- Ability to operate various maintenance equipment such as zero turn mowers, hand tools, and truck and trailer.

Preferred Skills:

- Preference will be given to applicants working towards a degree in Natural Resources or another related field.

Physical Demands/Work Hours:
